

Exceptional circumstance for refusal of bail in this case is not manifested from record. This opens the case of accused/petitioner to further inquiry.</p> <p>4. In view of above, this post arrest bail application is allowed, and the accused/petitioner is admitted to bail subject to submission of bail bonds in the sum of Rs. 80,000/- with two local, reliable and solvent sureties, each in the like amount to the satisfaction of this court.</p> <p>5.
