- 2. Their appointment to the service shall be subject to the following terms and conditions, besides, the condition mentioned above:
 - 1) They will be governed by the Khyber Pakhtunkhwa Civil Servants Act, 1973 and Khyber Pakhtunkhwa Government Servants (Appointment, Promotion & Transfer) Rules, 1989.
 - 2) They will be allowed the minimum pay of respective basic pay scales plus other allowances as admissible under the rules. Those who are already in government service and whose pay is more than the minimum of respective basic pay scales, will be allowed to draw pay as admissible per rules. Their pay shall be fixed at proper stage in respective basic pay scales.
 - 3) They will be governed by such rules and instructions relating to leave, T.A, and Medical Attendance as may be prescribed from time to time.
 - 4) They will be on probation initially for a period of one year extendable up-to two years.
 - 5) They will be eligible for continuance and eventual confirmation in the post on satisfactory completion of their probationary period, subject to availability of permanent posts and the completion of prescribed training, if any.
 - 6) Their services shall be liable to be dispensed with at any time without notice and assigning any reason before the expiry of the period of their probation/extended period of probation, if, their work or conduct during the period is not found satisfactory. In the event of termination from service, fourteen days notice or in lieu thereof fourteen days pay will be paid by the government. In case of resignation, they will give one month notice to the competent authority or in lieu thereof one month pay shall be forfeited to the government. The resignation shall, however, be subject to the acceptance by the competent authority.
 - 7) They will be governed by the Khyber Pakhtunkhwa Government Servants (Efficiency & Discipline) Rules, 2011 and Khyber Pakhtunkhwa Government Servants Conduct Rules, 1987 and any other instructions which may be issued by the competent authority from time to time.
- 3. If the above terms and conditions of appointment, also communicated vide separate letter, are acceptable to them, they should report for duty to the undersigned, immediately. The offer of appointment shall be deemed to have been cancelled, if they fail to report for duty to the undersigned within one month from the date of issue of this order.
