Note

- i. The MODs notified above shall ensure their presence at the station, round the clock, during the period of their duty.
- ii. In case an MOD is not available at the station, for the reason, whatsoever, the next in row shall perform his/her MOD duty, in addition to his/her own MOD duty.
- iii. In case an MOD, in dire need, avails any sort of leave, he/she shall mention in his/her application, about the fact that he/she is also the MOD. He/she shall not leave the station unless the leave so applied for, is granted and the alternate MOD is notified by this office.
- iv. The successor in court in case of transfer of any of the abovementioned officers shall automatically perform the MOD duty assigned to his/her predecessor in the above table.
- v. The MOD notified for Tehsil Headquarters, Ghazi shall deal with the matters pertaining to all the Police Stations of Tehsil Ghazi during respective period of duty. Likewise, during the period of any sort of leave availed by the Judicial Officer/MOD for Tehsil Headquarters, Ghazi, the other Judicial Officer will perform urgent/MOD duty pertaining to his court. In case of absence of all the Civil Judges/JMs, Ghazi for any reason, the MOD duty pertaining to Tehsil Headquarters, Ghazi shall be performed by the MOD, due to perform duty at District Headquarters, Haripur.
