The Committee shall undertake its assignment as per the following "Terms of Reference", with immediate effect:

TORs

1. The Committee shall complete "**Integrity Profiling**" of the Para-legal staff on the basis of feedback to be received from respective courts, learned members of the DBA, Haripur, track-record of the Para-legal staff, discreet enquiries and complaints.
2. The Committee shall conduct "**Spotting**" of the officials with dubious and vague credentials, who are believed to be prone to corruption.
3. The Committee shall recommend to the Authority appropriate disciplinary actions against the delinquent officials.
4. The Committee shall update the "**Integrity Profile**" of the Para-legal staff periodically and shall update and apprise the District & Sessions Judge about the progress on its assignment on monthly basis, in the meeting of Judicial Officers and shall also document the action taken on complaints of corruption against the Para-legal staff.


